Next steps for Municipal Election Candidates

1. File your Statement of Economic Interests- Within 5 Days

File online within 5 days at <https://ethics.alabama.gov>. Failure to file on time disqualifies your candidacy.

Save and share your confirmation with the City Clerk

2. Campaign Finance (FCPA Compliance)

If you raise/spend \$1,000.00 +, file reports online at <https://www.sos.alabama.gov>. Open a campaign account
Reports are due at set intervals before and after election.

3. Key Dates

Election Day: August 26, 2025

Runoff (if needed): September 23, 2025

Polls: 7:00 a.m. to 7:00 p.m.

4. Sign Rules

Follow the city rules for size and placement. No campaigning within 30 feet of polls. No signs on public property, utility poles, or ROWS
