## AN ORDINANCE AUTHORIZING THE CONVEYANCE OF CERTAIN REAL PROPERTY THAT WAS CONVEYED TO CITY OF OPP SUBJECT TO RIGHT OF REVERSION AND THAT IS CURRENTLY SURPLUS PROPERTY OF NO PUBLIC BENEFIT

WHEREAS, the City Council ("the Council") of the City of Opp, Alabama ("Opp"), acknowledges that certain real property as shown on the tax parcel map that is attached as Exhibit A (and incorporated herein) was conveyed to Opp subject to a right of reversion if Opp failed to commence construction of a sports complex on the property ("Subject Property") by December 1, 2021, as set forth in the Warranty Deed a copy of which is attached as Exhibit B (and incorporated herein).

WHEREAS, the Council never authorized the funding of the construction of the sports complex on the Subject Property, and, thus, construction of a sports complex was not commenced on the Subject Property prior to December 1, 2021.

WHEREAS, in addition, the Subject Property has remained vacant and is not used for any municipal or public purpose and is in fact surplus property that has reverted to the Estep Foundation per the Warranty Deed and a deed is due to be signed and delivered by Opp to the Estep Foundation as a formality to reflect the Estep Foundation's ownership of the Subject Property.

**NOW, THEREFORE, BE IT ORDAINED** by the Council that the following Ordinance is hereby adopted as follows:

## Subject Property to be Conveyed to Estep Foundation

Section 1. It is hereby found, established, acknowledged and declared that the Subject Property reverted to the Estep Foundation pursuant to the terms of the Warranty Deed, and, in addition, the Subject Property is surplus property in that it is not used for any public or municipal purpose, it does not serve any public benefit, and it is not needed for any public or municipal purpose.

Section 2. It is hereby found, established, and declared that Opp shall convey the Subject Property back to the Estep Foundation as a formality to acknowledge the condition of the Warranty Deed and to reflect the current ownership of the Subject Property.

Section 3. Pursuant to the Warranty Deed and the authority of § 11-47-20, Code of Alabama (1975), Opp is due to convey the Subject Property to the Estep Foundation, and the Mayor and City Clerk are hereby authorized and directed to execute and attest a Statutory Warranty Deed conveying title of the Subject Property to the Estep Foundation, and to take all other actions they deem necessary or prudent to effectuate the transfer of the Subject Property.

Section 4. This Ordinance shall become effective immediately upon its adoption and publication as required by law.
