Dedicated Vendor

I plan to attend the Opp Farmers Market every week during the season. If I am unable to attend, I will notify the Market Manager **by Wednesday prior**.

Visiting Vendor

I will attend on a week-by-week basis and will notify the Market Manager **by Wednesday prior** if I plan to attend.

*Note: Dedicated Vendor status does **not** guarantee a covered space. Covered spaces are assigned based on order of sign-up at the beginning of the season.*

Market Schedule & Operations

- **Season Dates:** May 2, 2026 until October 10, 2026
 - **Market Days:** Every Wednesday and Saturday
 - **Hours:** 7:00 AM to 2:00 PM, rain or shine
 - The market will close only in the event of **severe weather**.
 - Market hours may be extended on special event days.

Set-Up & Attendance Policy

- **Set-up time is 7:00 AM sharp. No exceptions.**
 - Vendors not in their assigned space by 7:00 AM may lose their space for that day.
 - Each vendor is assigned **one vendor space** and **one market table**, when available.
 - Vendors may bring up to **two 6-foot tables** of their own and must remain within their assigned space.
 - Vendors may not move or alter assigned tables or layouts.
 - If covered spaces are full, vendors may bring their own tent & table set up for the grassy area in front of the Farmers Market.

No-Show Policy

- Vendors are allowed **three (3) no-shows** per season.
 - After three no-shows, the market may no longer reserve space for that vendor.

Fees

- **Set-up at the Opp Farmers Market is free.**
 - Approval priority will be given to **produce vendors**. Non-produce vendors will be approved based on space availability, product mix, and market needs
-

Product, Permit & Compliance Requirements

- Farmers selling produce must provide a valid **State of Alabama Growers Permit**.

- Approved products include produce, eggs, plants, flowers, honey, jams, jellies, baked goods, and limited craft items.
 - All products must comply with **Health Department regulations**, Cottage Food Law requirements, and labeling rules.
 - Vendors are responsible for the safety and legality of their products.

Conduct, Safety & Cleanliness

- Vendors must keep their space clean and remove all trash at the end of each market day.
 - Smoking under the pavilion is prohibited.
 - Alcohol, drugs, gambling, and the sale of live animals are prohibited on market property.
 - Profane, abusive, or disruptive behavior is not permitted.
 - Vendors must be **16 years of age or older**. Minors may assist only when accompanied by an adult.

Market Authority & Communication

- The Market Manager has full authority to enforce all rules and regulations.
 - Fraudulent or dishonest practices may result in suspension or removal from the market.
 - All vendors are required to be members of the **Opp Farmers Market Vendors** Facebook group.
 - This group is the official platform for weekly check-ins, announcements, weather updates, and communication.
